AFFIDAVIT OF CHRISTOPHER SCHLESINGER

- I, Christopher Schlesinger, hereby depose and say as follows:
- 1. I have been in the food service industry since the age of 18. Following my graduation from the Culinary Institute of America in 1977, I have worked in 35 different restaurants, working with New England's most innovative chefs. In 1986, I opened East Coast Grill. In 1989, I opened Jake and Earl's Dixie BBQ, and in 1990, I opened the Blue Room. I am presently the chef and owner of All Star Sandwich Bar in Cambridge, Massachusetts. I am coauthor of five cookbooks, one of which won the James Beard Cookbook Award. I have coauthored a monthly feature on culinary issues in *The New York Times* and have written numerous articles for magazines such as *GQ* and *Food & Wine*. I am also a Contributing Editor for *Saveur* magazine. I have taught culinary students at the Culinary Institute of America and was the winner of the James Beard Award in1996 for "Best Chef of the Northeast." I am a founding member of the national organization Chefs 2000 and actively work with local farmers to preserve farming in New England. I also consider myself someone very knowledgeable in culinary history.

2. I know of no chef or culinary historian who would call a burrito a sandwich. Indeed, the notion would be absurd to any credible chef or culinary historian.

3. A sandwich is of European roots and is generally recognized in our industry as two pieces of leavened bread with something in between, typically slices of meat and/or slices of cheese. Although there may be other contents, including sliced vegetables, included in a sandwich, a sandwich is rarely, if ever, served with beans or rice in between the slices of bread. A sandwich is typically served cold.

4. A burrito, on the other hand, is specific to Mexico and is a food that is typically hot, with its contents being blended in a mix as they are rolled into a tortilla, a flat unleavened product originally from Mexico, that seals its contents in a blend inside as it is rolled and folded. Unless requested to leave out, a burrito always includes rice and beans. It typically contains a grilled chopped meat filling, choices of salsas, sour cream, guacamole, chopped tomatoes, grated cheese and lettuce.
